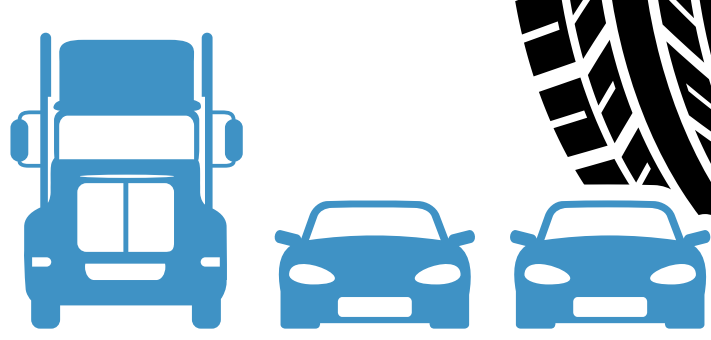

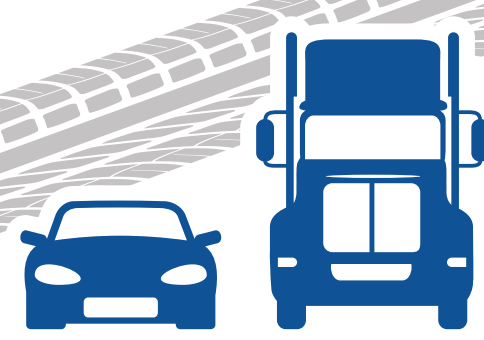

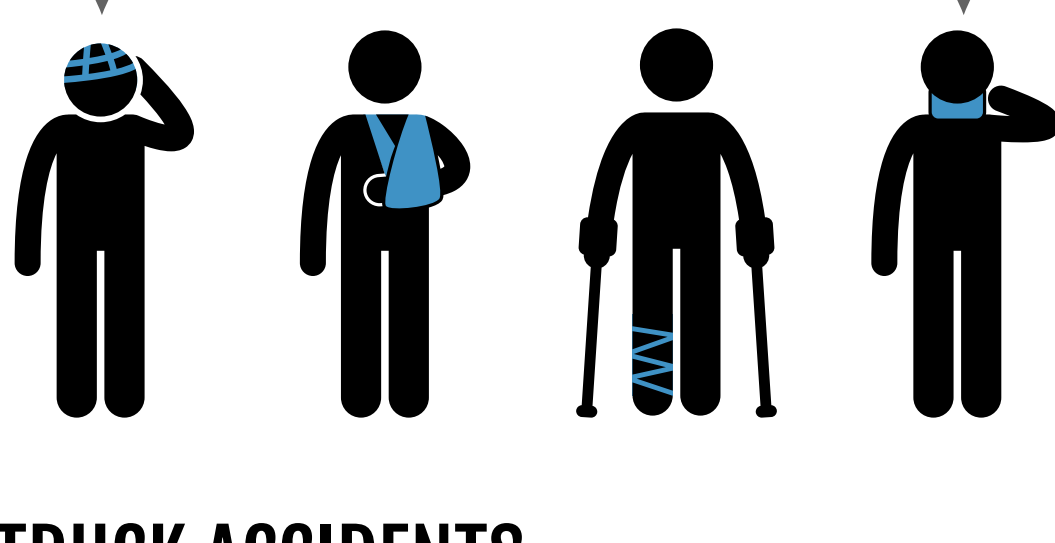

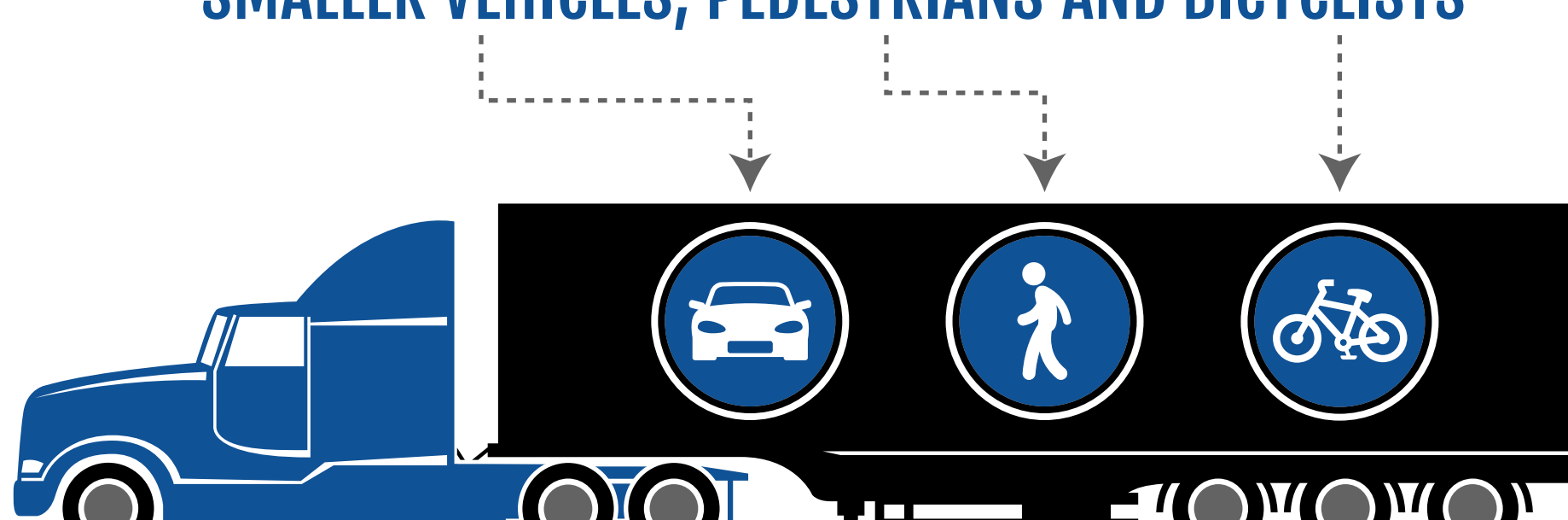

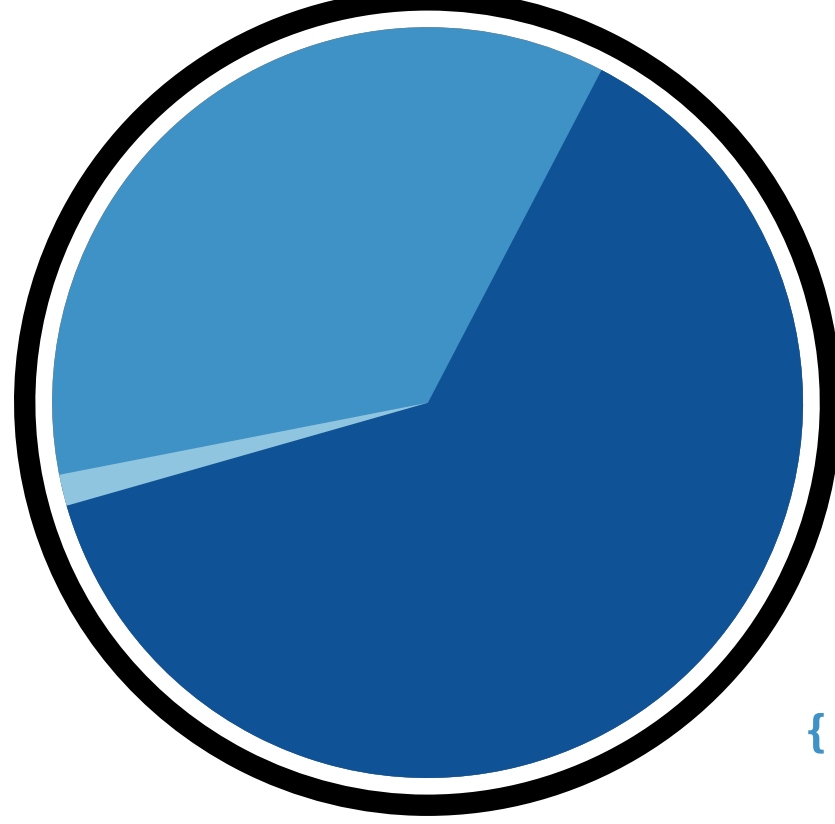


A CLOSER LOOK AT NEW YORK CITY TRUCK ACCIDENTS:

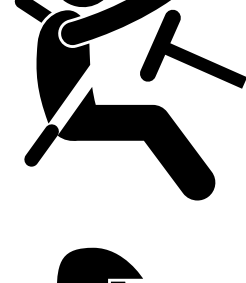

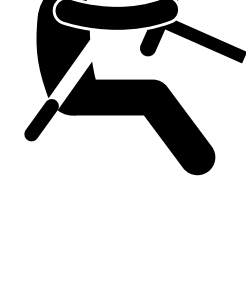
